Common Community Indicators

- Population
 - Count, Age, Race & Ethnicity, Migration, Wellbeing
- Finances & Economy
 - Unemployment, Wages, Poverty, Jobs, Industries
- Housing
 - Affordability, Owners & Renters, Value, Vacancy
- Natural & Built Environment
 - Land Use, Transportation, Climate, Pollution



Indicator Analysis

- A number by itself doesn't tell us much.
- Analysis techniques provide the context, the data story.

- Two primary forms of community data analysis:
 - Longitudinal/Trend analysis (Over Time)
 - Comparative analysis




Trend Analysis

- Vermont's Population in 2020 was 643,077
- So what?
- What does this mean?





200 Years of Vermont Population



Trend Analysis gives us a better understanding of where we currently are by allowing us to look back at where we've come from.



Comparative Analysis

- We have analyzed Vermont's population trend over time.
- So, what is the greater context?
- Comparative Analysis provides more of the story.

The Decennial Census

- Historically, the primary source for U.S. population data.
 - Enshrined in the Constitution.
 - Used for Redistricting and Reapportionment.
- Conducted every ten years.
 - But a ten-year data cycle is not timely.
- Enter: The American Community Survey(**ACS**).



EVOLUTION OF THE DECENNIAL CENSUS



1940-2000

Short form sent to ALL households.

Long form sent to a SAMPLE of households



1790-1830

One form sent to ALL households



2005

ACS yearly data collection begins from a SAMPLE of households





2010-Beyond

Only SHORT form sent to ALL households



The American Community Survey (ACS)

- Since 2010:
 - Continuous sample of the population
 - Annual data releases
 - Single & Multi-year estimates
 - 1-year estimates for areas with a population of 65,000 or more
 - 5-year estimates for all smaller areas



Decennial and ACS Contrast

Decennial Census

- Every ten years
- Core Demographics
 Population, home ownership, gender,
 age, race &
 ethnicity.

American Community Survey (ACS)

- Annual Updates
- All other Indicators Income, Poverty, Transportation, Disability, Employment, Housing, etc.

- Annual Surveys of Governments- Detailed government structure, organization, function, finances, and employment.
- Census of Governments- Organization, employment, and finances of all state and local governments.
- Commodity Flow Survey- Data on the movement of goods originating from the United States.
- Decennial Census- Total population count with Age, Sex, Race & Ethnicity. Constitutional Mandate used for Reapportionment.
- **Economic Census** Detailed industry and business data.
- Survey of Business Owners- By industry and by Gender, Ethnicity, race, and veteran status of owners.
- Population Estimates Program- Estimated population totals
